INFORMATION CLAUSE

Pursuant to Article 13-14, 1–2 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27.04.2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (OJ L 119, p. 1) – GDPR – we inform that:

I. The controller of personal data

To provide, improve and analyse the services, the Administrator uses the services and tools of third parties entities, such as, among others, Google Analytics. The Website uses Google Analytics tools provided by Google Inc. with its registered office in the USA (hereinafter: Google) – an analytics service carried out with the use of cookies. The information generated by cookies on your use of the Website available at https://policies.google.com/privacy?hl=pl, and is transmitted to and stored on a Google server in the USA. The Service uses IP anonymisation, which pre-trims IP addresses of Google users from the Member States of the European Union and from any other countries that are a party to the Agreement on the European Economic Area. Google uses the information collected to verify your use of Administrator's services, create reports on their functionality, and to provide additional services to the Administrator related to the use of digital services or the Internet, which includes in particular Google analytics reports on the services provided according to demographic criteria and interests. - a) The implementation of the concluded contract in which the Controller is a party (the legal basis under Article 6.1b GDPR).
- b) The possible establishment, exercising or defence of legal claims as the implementation of the legitimate interest of the Controller (the legal basis under Article 6.1f GDPR).
- c) The implementation of the obligations under the law, e.g. tax, accounting obligations (the legal basis under Article 6.1c GDPR).
- d) sending commercial offers of the controller, being the pursuit of the legitimate interest which is direct marketing of own products and services (legal basis Article 6.1f GDPR).

We ask you not to provide information of special categories of personal data, such as racial or ethnic origin, political opinions, religious or philosophical beliefs, trade union membership and the processing of genetic data, biometric data for the purpose of uniquely identifying a natural person, or data concerning health, sex life or sexual orientation of this person.

III. Automated decision-making (profiling)

Your personal data will not be processed by automated means and will not be profiled.

IV. Period for which the data will be stored

The time during which we can process your personal data is determined by the legal basis that constitutes the legal premise for the processing of personal data by the Controller. Accordingly, we inform that:

- a) We store your data obtained for the purpose of entering into a contract throughout the time when the contract is negotiated and to the end of the calendar year following the year in which you contacted us for the last time as regards its conclusion.
- b) Your personal data obtained with regard to entering into the contract will be processed by us throughout the time of the performance of the contract.
- c) If the Controller processes personal data because it is mandatory due to the applicable law, the periods for which the data will be stored for this purpose are defined in these laws, e.g. tax provisions or rules on data archiving obligations.

If the Controller processes personal data on the basis of the legitimate interest of the controller, the processing will continue until the cessation of the above interest (e.g. the limitation period for civil law claims) or until the objection of the data subject against such further processing, in the situations when such objection is allowed under the regulations of the applicable law.

V. Data recipients

Your personal data may be made available to the following recipients or categories of recipients:

- The entities providing cloud systems in which personal data are stored; The entities providing hosting services;
- The entities providing transport services;
- The entities providing hotel services;

VI. Rights of data subjects

You have the right to lodge a complaint with the President of the Polish Supervisory Authority when you decide that the processing your personal data infringes the GDPR provisions.
